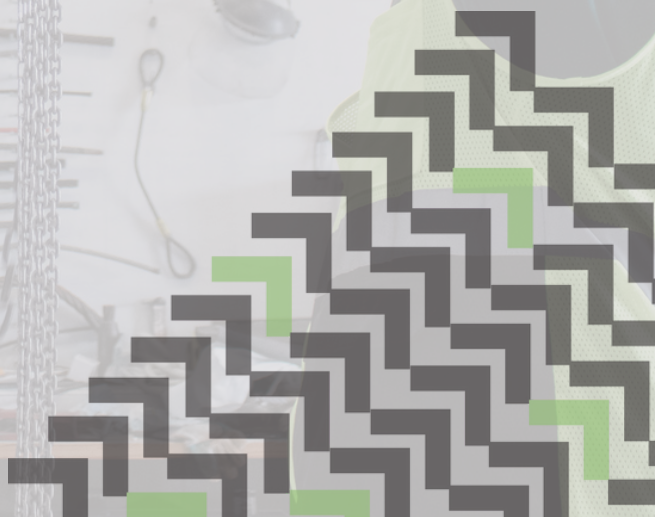

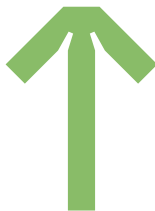

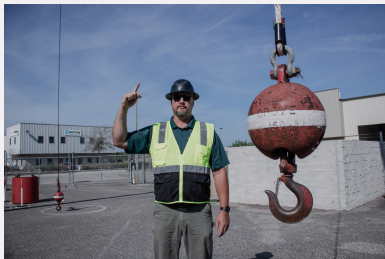

EQUIPMENT INSPECTIONS

Depending on the governing bodies of our customers' material handling and lifting equipment, our inspectors, who are employees of CICB (Crane Inspection & Certification Bureau), are all trained, competent, qualified CCO Certified, and accredited for inspecting cranes of all types including:

Equipment inspections are performed to the requested standards or corporate policies and procedures. These include OSHA, ANSI/ASME, CMAA, USACE 385-1-1, AFOSH, NAVFAC P-307, DOE, DOD, API, Loler, and BS7121 Standards and Laws.

CICB is accredited by OSHA in 29CFR Part 1919 for providing Maritime Annual and Quadrennial crane and rigging gear inspections, for those cranes used to load and off load goods for sale in commerce.

PERSONNEL EVALUATIONS

IN FEBRUARY 2019, OSHA INTRODUCED THE MANDATE THAT EMPLOYERS EVALUATE EVERY OPERATOR TO ENSURE THEY ARE QUALIFIED.

The ruling is recorded under the Cranes and Derricks in Construction Standard in 29 CFR 1926 Subpart CC.

It establishes that it is the employer's responsibility to ensure that each Mobile Crane Operator is

- (1) trained to operate the crane type(s) for which certification will be issued;
- (2) has obtained certification/licensing in accordance with Subpart CC; and
- (3) is evaluated by the employer to ensure each operator can safely operate the equipment that will be used.

As part of its update to Subpart CC, OSHA ruled that the employer must evaluate the crane operator using an individual

"who has the knowledge, training, and experience necessary to assess equipment operators." [1926.1427(f)(4)]

Recognizing that not everyone has an employee that meets these requirements, OSHA also allows for an agent of the employer to conduct these evaluations.

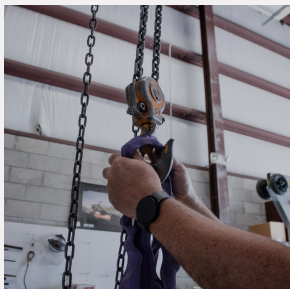

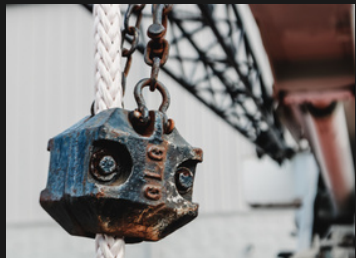

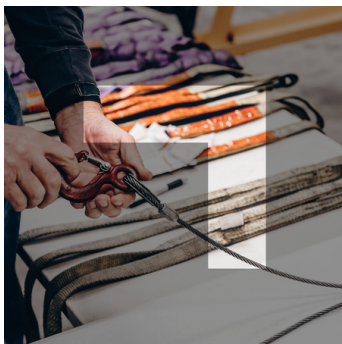
